**DOUGLAS MAYANJA** is Curator at St. Luke Community Museum Kyotera, Uganda. He has been involved in heritage and museum issues for some years, informed by the cultural activities and practice of his community, which emphasized respect for the natural and social cultural heritage. His postgraduate education background

in Museum and Heritage Studies, and his undergraduate studies in Tourism opened his way. His interest is to encourage participation by the community in the complicated process related to the conservation of cultural heritage and to enhance positive cultural practice for the development of African cultural diversity.

**YURIL MAZUROV** is Professor at the Faculty of Geography, Moscow State Lomonosov University, Moscow, Russia. He lectures in Heritage Studies as well as on Sustainable Development, Environmental Economics and Management. An expert on education for sustainable development, he has been the Head of Department, Russian Heritage Institute for many years. He is also Councilor of the Russian National Center for Heritage Trusteeship since its creation and has participated in INTO conferences since 1995.

**S.K. MISRA** is Chairman, Indian Trust for Rural Heritage and Development (ITRHD) and Vice-Chairman Emeritus, INTO. After a government career in which he headed several different



Ministries (including Tourism, Civil Aviation, and Agriculture), S.K. Misra retired as Principal Secretary to the Prime Minister of India. He then served for ten years as Chairman of INTACH, the Indian National Trust for Art and Cultural Heritage. In 2011 he established the Indian Trust for Rural Heritage and Development (ITRHD).

He is the Vice-President of the Alliance Francaise in India, and in 2009 was awarded the Padma Bhushan (India's 3rd highest civilian award) by the President of India for distinguished civil service.

**PROFESSOR SIMON RICHARD MOLESWORTH AO, QC**, is the foundation Chairman of the Executive of the International National Trusts Organisation ("INTO"). Since 2009, the International Affairs Ambassador of the Australian Council of National Trusts. A councillor of the National Trust of Australia (Victoria) from 1980-2005, and its honorary chairman and then president for just under 20 years. A board member of the ACNT for 21 years and its chairman 2001-06. A Commissioner of the Australian Commonwealth's Australian Heritage Commission for 5 years from 1987 and from 1996-2010, member of the Australian Government's National Cultural Heritage Committee, responsible for the Protection of Moveable Cultural Heritage Act. In practice, a barrister since 1984, he was appointed a Queen's Counsel in 1995

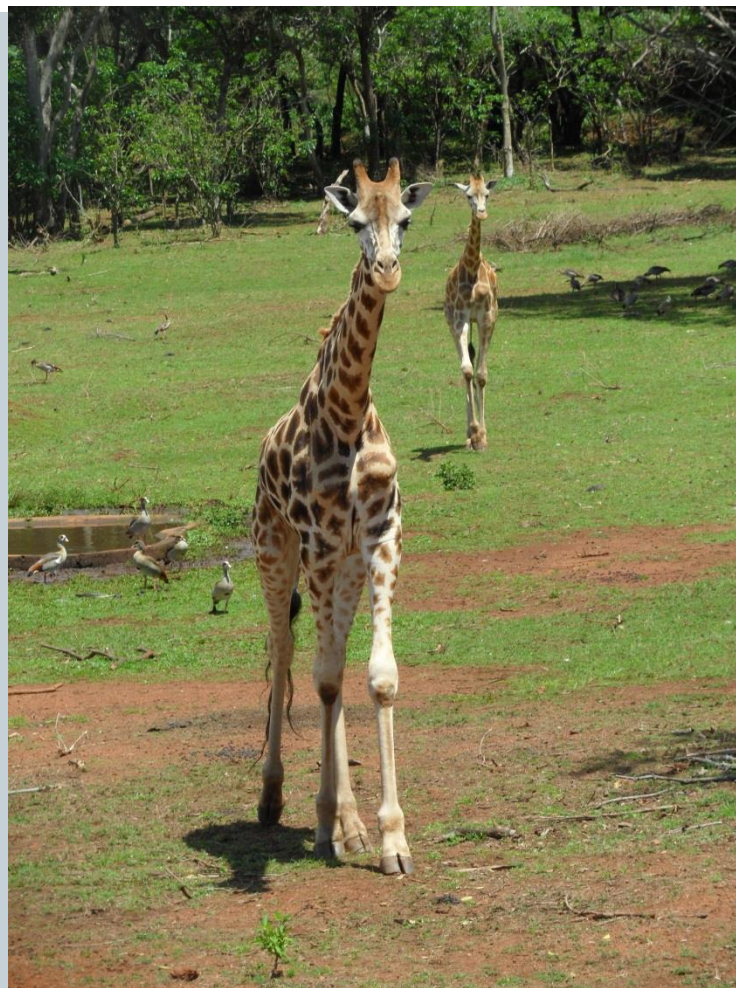

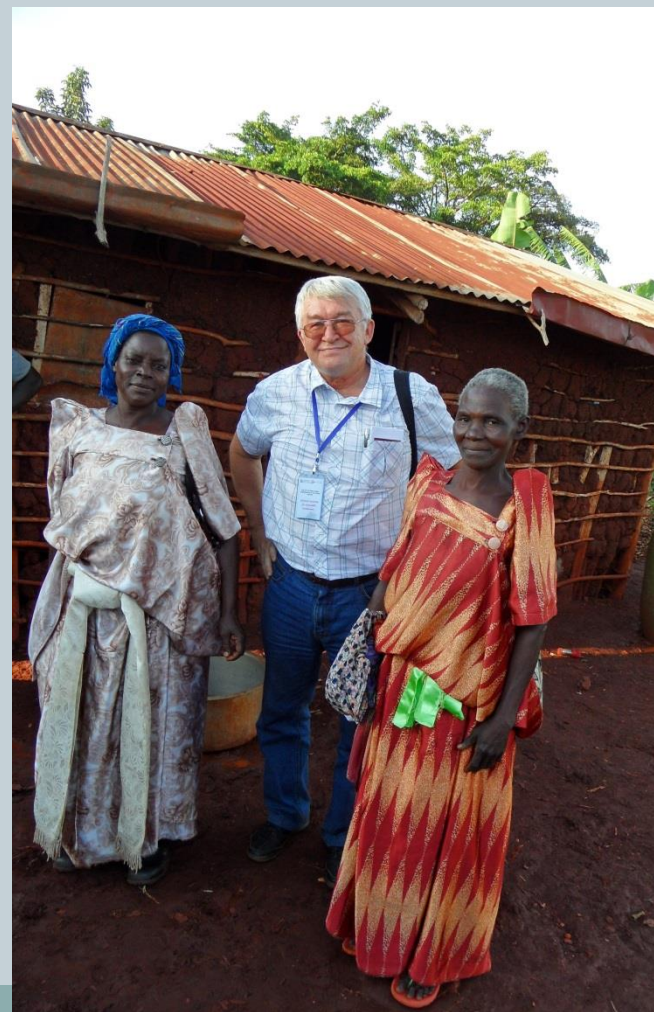

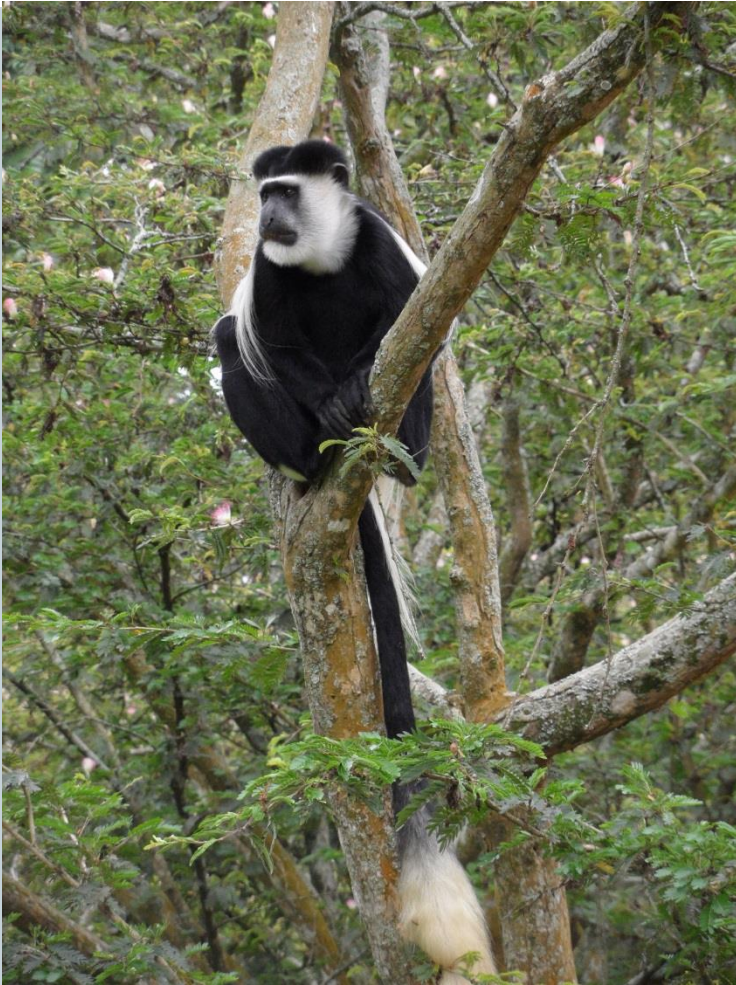

## **THE ENTEBBE DECLARATION** **CALLING FOR GLOBAL ACTION TO PROTECT TANGIBLE** **AND INTANGIBLE HERITAGE, ESPECIALLY WITHIN** **DEVELOPING NATIONS**

**Whereas:** The overarching mission of the International National Trusts Organisation ("INTO") is to promote the conservation and enhancement of the cultural and natural heritage of all nations for the benefit of the people of the world.

**Whereas:** In furtherance of this mission, INTO has objectives, amongst others, to pursue advocacy in the interests of conservation of cultural and natural heritage and to formulate and promote conservation best practices.

**Whereas:** At the 10<sup>th</sup> International National Trusts Conference in Edinburgh, Scotland, in September 2003 members of the then International Network of National Trusts and allied organisations adopted the **Edinburgh Declaration for the Improved Protection of Cultural and Natural Heritage at the National and Local Levels** ("Edinburgh Declaration")

**Whereas:** At the 12<sup>th</sup> International National Trusts Conference in New Delhi, India, in December 2007, on the occasion of the formal launch of INTO, the Charter of INTO was agreed, in which it was specified that one of INTO's objectives is to advance the objectives of the Edinburgh Declaration.

**Whereas:** The objectives of the Edinburgh Declaration remain vitally relevant globally but no more so than within and amongst Developing Nations where comparative disadvantage compared to the Developed Nations is such that progress has been far too slow in achieving the necessary reforms to secure the conservation of cultural and natural heritage and to formulate and promote conservation best practices within these Nations.

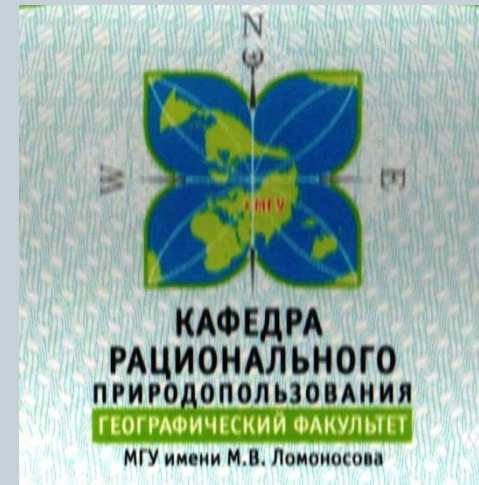
**AND NOTING** that UNESCO, the United Nations Educational Scientific and Cultural Organisation, convened an International Congress "Culture: Key to Sustainable Development" in Hangzhou China in May 2013 at which the participants adopted the **Hangzhou Declaration Placing Culture at the Heart of Sustainable Development Policies** ("Hangzhou Declaration") which is highly relevant to the concerns of INTO.

**NOW BY THIS THE ENTEBBE DECLARATION** members of INTO and other delegates representing cultural and natural heritage organisations gathered in Entebbe, Uganda, and those who subsequently endorse it, **both embrace the Hangzhou Declaration and reconfirm the Edinburgh Declaration** whilst stressing the particular challenges of Developing Nations faced with comparative inequality and disadvantage which must be overcome in order to achieve the conservation of tangible and intangible heritage.
